Civil Writ Petition under Article 226/227 of the Constitution of India for issuance of writ in the nature of mandamus directing the respondents to grant the Statutory pay scale to the petitioners as per 2009 Rules Annexure P-4 i.e. Rs.10300-34800 Grade Pay of Rs.5000/-later on Grade Pay increased to 10300-34800 + Grade Pay vide letter dated 27.02.2012 Annexure P-5 from entry into service along with arrears at interest rate of 12% thereon (the petitioners demand 6<sup>th</sup> Pay scale/ Commission, of Punjab State Government) and with a further prayer that issue a writ in nature of Mandamus directing the Respondents to take into account the statutory pay scale of Rs.10300-34800 Grade Pay of Rs.5000/-later on Grade Pay increased to 10300-34800 + Grade Pay vide letter dated 27.02.2012 Annexure P-5 with Future Pay Revisions.

AND/OR

Issue Writ in the nature of Mandamus, directing the Respondents, struck down the instructions dated 17.07.2020 Annexure P-3 and release the benefit to the petitioners under the judgment in

CWP No. 15896 of 2023 titled Dr. Saurabh Sharma and others Vs. State of Punjab and others and under the judgment in CWP No. 17064 of 2017 titled Ajay Kumar Singla and others Vs. State of Punjab and others, notification dated 15.01.2015 quashed and released the full salary to the petitioners during probation period, which were allowed in favour of the petitioners.

1. Prayer made in the present petition for directing the respondents to grant the pay scale as per the statutory rules with regard to which reliance is placed on the judgment of this Court in *Saurabh Sharma and others vs. State of Punjab and another*, CWP-15896-2023, which was allowed on 13.09.2024 against which LPA-2977-2024 has also been dismissed on 10.12.2024. Regarding the claim raised in the present petition, a representation dated 07.02.2025, Annexure P-8, has been submitted to the respondents, which has yet not evoked any response. He, on instructions, prays that a direction be given to the respondents to decide the same keeping in view the aforesaid judgment, in a time bound manner, to which learned State counsel has no objection.

2. In view of the above and without commenting upon the merits of the case, this petition is hereby disposed of with a direction to the respondents to decide the representation dated 07.02.2025, taking note of the aforesaid judgment, within a period of 6 months, which this Court has no reason to believe the authorities would not address in a just, fair and reasonable manner. Upon doing so, after notice and hearing offered to them and if found entitled, grant the benefit forthwith. Needless to say, if the orders are adverse to their interest, the same shall contain reasons and the petitioners shall be free to seek legal redress thereupon.
