The Ministry of Health and Family welfare under the NAPRE 2030 program (aiming to eliminate rabies deaths by 2030), directs NGO's to conduct Humane Education and awareness sessions in Schools. We at Peedus People work under the same program.

The importance of Humane-Education in creating empathetic, kinder, well-rounded citizens is well documented. Several governments have added Humane education in their extra-curricular activities at Government schools (pls see annexure A- Order from Chandigarh, Delhi Municipal Corporation and State Government, Punjab < Mohali & Amritsar District>, Maharajganj Uttar Pradesh, Gujrat, Tamil Nadu).

We are collaborating with HMEL (Guru Gobind Singh Refinery), under their CSR initiative to provide the above workshops in the Bathinda District government schools. HMEL works with 100+ schools in the area and we are planning to run these workshops in those schools. This is for your information and action regarding the same.

We will conduct sessions in all government schools about the following:

"How to read a dog's body language and avoid dog bites."

"What is rabies? How it spreads and can be avoided"

Learning Objective -This 30 minute interactive session helps children and parents avoid dog bites and understand Rabies, rather than being afraid of it and panicking. Goal: Very effective in creating awareness about dog-bite prevention, rabies and co-existence.

Desired effect on Child development: As our programs relate kindness to animals and kindness to fellow humans, the overall desired effect is to create kinder, humane, aware and more tolerant citizens.

Plan: We would like to hold workshops in Bathinda area Schools. We target students from Grades 4th to 7th. This workshop is held at the convenience of the school so it does not disturb their regular coursework.

Reporting: Report on the effectiveness of the workshops.

Cost: There is no cost associated with these workshops.

We believe we are perfectly poised to deliver these lessons in a fun, innovative way.

The finding of the project should be shared with the Directorate of Education & not to be published to say media / Distributional (Contains).

- There shall be no uploading of the images/pictures/videos of the students on social media pages except with the prior written permission of the Director (Education).

 The Organization has to ensure that no damages occur while conducting the programme. It will be the sole responsibility of the Organization & it should be rectified to the entire substaction of the HoS, if there is any damage
- The permission is purely provisional & liable to be withdrawn at any time. If it is found to be against the national interest or causes any type of obstruction in the functioning of DoE as well as violation of these terms & conditions.

- 12. The DoE will indemnify against any legal/financial liability/litigation that may arise out of the project process or its findings
