CIVIL WRIT PETITION UNDER Articles 226 of the Constitution of India, 1950 for issuance of an appropriate writ, order or direction in the nature of MANDAMUS directing the respondents to maintain the parity in granting Grade Pay being paid to School Librarians including the present petitioners working in the Department of Education Senior Secondary and to grant to the petitioners similar pay band of Rs.5910-20200+3000 GP and thereby, petitioners be held entitled for pay scale of Rs.29200/- as per matrix of 7th Central Pay Commission as mentioned at serial No.13 of the said instructions/ Notification dated 21.10.2020 (Annexure P-10) from the date of their respective joining alongwith all consequential benefits and arrears with interest @ 12 % per annum;

AND

Further, with a prayer for issuance of a writ, order of direction in the nature of MANDAMUS to amend/ correct the Notification dated 21.10.2020 (Annexure P-10) issued by Department of School Education, Punjab to the extent whereby the school librarians have been granted consolidated pay of Rs.25500/- as per pay scale/ matrix of 7th Central Pay Commission by considering the Pay Scales of School Librarians as per 5th Pay commission as on 01.01.2006 and as per table notified in 2009, in the pay band of Rs.5910-20200+2400GP; which is factually wrong and arbitrary and lead to anomaly and disparity in Grade Pay among school librarians, because i) all the School

Librarians working in different schools in the State of Punjab are being paid salary in the pay scale of Rs.5910-20200+3000GP w.e.f. 01.01.2006 in view of the instructions conveyed by the Government of Punjab, Department of Finance, vide letter dated 26.04.2007 (**Annexure P-1**) ii) in view of the Punjab Civil Services (Revised Pay) (Second Amendment) Rules, 2009 as per which School Librarians or Assistant Librarians who possesses educational qualification of 10+2 with two years Diploma in Library Science were granted pay band of Rs.5910-20200+3000GP against pay scale of 4550-7220 as per item NO.9 of the conversion table attached to said amended Rules of 2009 and whereas School Librarian having qualification of Matriculation with one year Diploma in Library Science were granted pay band of Rs.5910-20200+2400GP against pay scale of Rs.4020-6200 as per item NO. 7 of conversion table, of the said amended Rules, 2009 and since all the petitioners having qualification of 10+2 with two years diploma and above; iii) also in view of the recent decision of this Hon'ble Court passed in CWP NO. 23758 of 2017 decided vide order dated 02.12.2024 (**Annexure P-5**) based on Notification dated 06.11.2011 (**Annexure P-2**) and also in view of Judgment of this Hon'ble Court passed in CWP NO. 16875 of 2007 decided on 28.05.2012 (**Annexure P-3**) and as such, the said instructions / notification

dated 21.10.2020 (Annexure P-10) in this respect are liable to be corrected;

And

AND/OR

Further prayer is for issuance of a writ in the nature of MANDAMUS directing the respondents to decide the representation dated 22.04.2025 (Annexure P-11) (bearing receipt No. 4141443 and also sent through registered post on 23.04.2025) in a time bound manner in which disparity of Grade Pay has been raised;

AND/OR

Further prayer is for issuance of any other appropriate writ, order or direction, which this Hon'ble Court may deem fit and proper in the peculiar facts and circumstances of the case in the interest of justice:

RESPECTFULLY SHOWETH:

1. That the petitioners are working as School Librarians in different schools in the State of Punjab, under the Government of Punjab, department of Education (Secondary), SAS Nagar Mohali and are residents of different places in the State of Punjab and as such, the petitioners being citizen of India and are resident within the ordinary writ jurisdiction of this Hon'ble Court and as such, the petitioners are competent to invoke the extra-ordinary and inherent writ jurisdiction of the Hon'ble Court as envisaged under article 226 of Constitution of India.
2. That the Government of Punjab vide its Notification dated 26.04.2007, decided to grant Pay Scale of Rs.4550-7220 to the

1. Learned counsel contends that the petitioners were recruited through a common advertisement dated 02.04.2021, Annexure P-7, with the same qualifications, however, similarly circumstanced School Librarians having the same qualifications deployed in other schools, are drawing grade pay of Rs.3,000/- while they are getting Rs.2,400/-, regarding which a representation dated 22.04.2025, Annexure P-11, has been submitted, which has yet not evoked any response. He, on instructions, prays that a direction may be given to the respondents to decide the same in a time bound manner.

2. Learned State counsel has no objection to the limited prayer made.

3. In view of the above and without commenting upon the merits of the case, this petition is hereby disposed of with a direction to the respondents to decide the representation dated 22.04.2025, within a period of 6 months, which this Court has no reason to believe the authorities would

not address in a just, fair and reasonable manner. Upon doing so, after notice and hearing offered to them and if found entitled, grant the benefit forthwith. Needless to say, if the orders are adverse to their interest, the same shall contain reasons and the petitioners shall be free to seek legal redress thereupon.
